His main objective is to listen to his peers and then direct them to agencies that might be able to help them. The main reason people come to PC is grief, loneliness, tired sad, and stressed about the issues of growing older. Listening being the most important component of his counseling.

Kathi added that she has a background in Drug and Alcohol Counseling and found Peer Counseling a good fit when she retired. The PC works with an average of 25 clients under the supervision of a clinical psychologist. The counselors also receive 10 weeks of extensive training.

People contact Peer Counseling via ads in the MT. Democrat, Around there Magazine, Brochures and individual referrals. Clients must however, make the contact call themselves.
